



On This Day, the UAE and Bahrain Will Sign the Agreement with the Jewish State of High Treason for Palestine The Site of the Isra' and Mi'raj of the Messenger (saw) ... Without fearing Allah, His Messenger and the Believers

France 24 published vesterday 14/9/2020: ("A new era for the Middle East will be charted Tuesday when the UAE and Bahrain sign agreements to recognize Israel [normalize relations], in Washington...[It is decided that US President Donald Trump will oversee it during the signing ceremony at the White House].....Alongside them will be foreign ministers from the two Gulf states who will ink a deal...") That is, the United Arab Emirates and Bahrain will sign today, Tuesday, in that black capital Washington, the agreement of high treason for the Messenger of Allah's (saw) location of the Isra' and Mi'raj without fearing Allah, His

Messenger and the believers! They are thus following the path of their likes before them: the Egyptian regime in Camp David, the PLO in Oslo, and the Jordanian regime in Wadi Araba! The rulers in Muslim lands, before and after these signatures, were dealing with the Jewish state, but from behind a cover, observing a measure of modesty, but rather of shame, and were normalizing with them from behind a curtain. But when this was removed, the declaration of the normalization became 'a source of pride', that they announce without feeling humiliated or some shame! This humiliation will befall on them, whether they admit that or deny



it, as is the fate of anyone who commits a crime against his Deen and Ummah.

[سَيُصِيبُ الَّذِينَ أَجْرَمُواْ صَغَالٌ عِندَ اللهِ وَعَذَابٌ شَدِيدٌ بِمَا كَانُواْ يَمْكُرُونَ]

"There will afflict those who committed crimes debasement before Allah and severe punishment for what they used to conspire" [Al-An'am: 124].

It is one of the greatest sins, that this is taking place, as normalization proceeds rapidly in full view of the Ummah and its army! And without the Muslim armies moving to turn the world upside down on them and remove them! Moreover, those who have not signed declared agreements yet are not below the level of the signatories, for Oman hosts and is hosted by the Jewish state, and Qatar is an impartial mediator between the Jews and Gaza! The Saudi regime in the land of the Two Sacred Mosques (al-Haramain) has opened its airspace for the warplanes of the monstrous state that occupies the sacred Al-Quds of Muslims!! And the Turkish regime still recognizes the occupying Jewish state of Palestine! Indeed, it is one of the gravest sins that this is taking place, as if it is a normal matter between brothers and it does not exceed a difference in views on the demarcation of borders!!

O Muslims: Palestine is the blessed land, the land of Al-Quds, the land of Isra' and Mi'raj, it is in the hearts of the Muslims, even if they are afflicted with the Ruwaibidha (ignorant) rulers who obey the colonial kuffar above the obedience of the Lord of the Worlds. Palestine and its Al-Quds is the Palestine of the Muslims, and not of those treacherous rulers. The normalization of their relations with the Jewish state, the usurper of Palestine, will crown them with shame and humiliation until the day they are promised, because Palestine will return to its people after fighting the Jews, the occupiers of the blessed land on a memorable day, that will be filled by the chant of takbeer of the Muslims' armies; indeed it is a true promise made by the Al-Sadig Al-Masdoog (saw) (the honest and trustworthy).

(لَتُقَاتِلُنَّ الْيَهُودَ فَلْتَقْتُلْنَّهُمْ، حَتَّى يَقُولَ الْحَجَرُ يَا مُسْئِمُ هَذَا (لَحَجَرُ يَا مُسْئِمُ هَذَا You will fight against the Jews and you will kill them until even a stone would say: Come here, Muslim, there is a Jew (hiding himself behind me); kill him." (Narrated by Muslim).



O Muslims: The armies in Muslim countries are your sons, your brothers and from you, and in them are the sincere ones, so enlighten their insight with the truth and push them towards it to save Palestine from the monstrous Jewish entity, that occupied it and spread corruption and corrupting in it with the support of the rulers in Muslim countries; who instead of fighting that entity they protected its security! Otherwise, this entity would not have survived to this day, since the Jews will not be aided in a serious fight with the Muslims.

لَن يَضُرُّوكُمْ إِلاَّ أَذًى وَإِن يُقَاتِلُوكُمْ يُوَلُّوكُمُ الأَدُبَارَ ثُمَّ لاَ يُنصَرُونَ] "They will not harm you except for [some] annoyance. And if they fight you, they will show you their backs; then they will not be aided" [Al-Baqara: 111]. This is their reality, and this is their affair, but instead of fighting them, the rulers reconciled with them, and instead of driving them out of our homes, as in the saying of Al-Aziz al-Hakim:

[وَاقْتُلُوهُمْ حَيْثُ ثَقِقْتُمُوهُمْ وَأَخْرِجُوهُم مِّنْ حَيْثُ أَخْرَجُوكُمْ]

"And kill them wherever you overtake them and expel them from wherever they have expelled you" [Al-Baqara: 191]. Instead, these tyrants consolidate them on it!

[قَاتَلَهُمُ اللهُ أَنَّى يُؤْفَكُونَ]

"May Allah destroy them; how are they deluded?" [Al-Munafiqun: 4].

O Muslims: This matter will only be resolved in the way it was resolved at the beginning: the ruling by what Allah has revealed and armies that shake the enemies of Allah (swt), and this will not happen except by the return of the Khilafah Rashidah (rightly-guided Caliphate) on the method of Prophethood again. So it will uproot the entity of Jews that desecrated the pure Palestine for more than seventy years, and then Palestine will return completely to the lands of Islam, a dear country in a dear state, a Khilafah (Caliphate) on the method of Prophethood ... And this will materialize, Allah willing, it is confirmed with definite evidences by four matters:

First: The Muslim Ummah is the best nation brought to humankind.

"You are the best nation produced [as an example] for mankind" [Al-i-Imran: 110]. And a nation of this state will not be patient on injustice, it will therefore not forget its Al-Quds, no matter what tyrants do, but rather it will trample over them with its feet ...

Second: A promise from Allah of succession on earth

[وَعَدَ اللَّهُ الَّذِينَ آمَنُوا مِنكُمْ وَعَمِلُوا الصَّالِحَاتِ لَيَسْتَخْلِفَنَّهُم فِي الْأَرْضِ]

"Allah has promised those who have believed among you and done righteous deeds that He will surely grant them succession [to authority] upon the earth" [An-Nur: 55]. And a glad-tiding from the Messenger (saw) of the return of the Khilafah on the method of Prophethood.

«ثُمَّ تَكُونُ خِلَافَةٌ عَلَى مِنْهَاج النَّبُوَّةِ»

"And then there will be Khilafah (Caliphate) on the method of Prophethood" (Extracted by Ahmad).

Third: The Hadith of Al-Sadiq Al-Masdooq (saw) (the honest and trustworthy) of fighting and killing the Jews. <لْتُقَاتِلُنَّ الْيَهُودَ فَلْتَقْتُلُنَّهُمْ، حَتَّى يَقُولَ الْحَجَرُ يَا مُسْلَمُ هَذَا يَهُودِيٍّ فَتَعَالَ فَاقْتُلْهُ»

"You will fight against the Jews and you will kill them until even a stone would say: Come here, Muslim, there is a Jew (hiding himself behind me); kill him." (Narrated by Muslim)

Fourth: A sincere, loyal party, Allah willing, working to fulfill the promise of Allah Almighty, and the glad tidings of His Messenger (saw). It is a pioneer that does not lie to its people, one with sight and insight, it leads the Ummah to the good that revives it with glory and triumph, and victory in the two worlds, and glad-tiding to the believers.

And an Ummah that has these pillars of victory, Allah willing, it will establish its Khilafah (Caliphate) and liberate its Al-Quds, and eliminate the source of the oppressors and their masters and aides.

Covid-19 pandemic brought pain and relief to Kenyans. Pain as a result of the ravage emanating from it spanning from economic shutdown that gave rise to unemployment soaring 5.2 % to 10.4 % (The Star, 01/09/2020), social anguish as relatives lost their loved ones, savings wiped out in the course of seeking treatment and places of worshipping shutdown indefinitely. In addition, the school calendar was slashed leaving education stakeholders including but not limited to parents, students and teachers in total mayhem especially to class 8 and form 4 students since KCPE and KCSE certificates are considered a gateway to world of

opportunities. As for the relief it was due to the stop of the political bickering that was growing as a result of the so called proponents and antagonists of the BBI. For the first time the paupers and elites were united in fear for their lives despite their circumstances being different because the poor cannot afford the medical bills while the rich can afford but there was no cure!

As for the Kenyan government Covid-19 was a blessing since it took advantage to satisfy its gluttonous appetite and approached financial institutions at the regional and international level to borrow heavily from them in the pretext of fighting the pandemic.



On the other hand, it plunged further the country into further depth of debts that is approaching Sh.7 trillion soon. For instance, between March and June 2020, Kenya took a total of Sh.410 billion debt approximately Sh136 billion monthly or Sh.4.5 billion daily! (Daily Nation, 09/09/2020). Since, the so called opposition does no longer exist from the moment the handshake took place on Friday, 9 March 2018. Therefore, the Kenyan government implements whatever policy it wishes with no worries since there is no one to account it.

The most deceptive narrative currently being peddled around is that of the so called hustler, led by William Ruto and dynasty, led by Uhuru Kenyatta, Gideon Moi and Raila Odinga groups. The citizens are striving to align themselves with these groups. The most disheartening part is that the groups enjoy support from the so called thinkers and scholars! The unifying factor reminiscent of these two groups is that leaders from both camps are tantamount to wolves who have covered themselves with sheep's wool in order to prey against the majority unaware citizens who suffer from the UGALI syndrome! The syndrome is dangerous as it is established in the secular capitalist education system upon the principle of not providing opportunities for the masses to think critically without external influence of their future since their lives are made deliberately busy chasing for UGALI to satiate their temporary hunger. Therefore, the two camps are not strangers in the political arena but have reinvented themselves to exploit the masses via tribal cocoons. They are the custodians of the invalid secular (separating religion from state/life) capitalist ideology that is the root cause of the myriads of challenges facing Kenya since the 'false flag independence' in 1963. They have strived to implement the secular capitalist ideology and its venomous system including the democratic system of governance responsible for unlimited human freedoms that are causing havoc to humanity, economic system responsible of unlimited taking of interest based loans and exploitative taxation approaches, foreign policy drawn by the colonial masters to protect their interests, education system responsible of building secular identities concerned with sensual gratifications etc.



The said groups are alleging to be calling for change but within the same secular capitalist box that is the source of problems not only in Kenya but globally!

In Islam, Muhammad ibn Abdullah (saw) لاَ يُلْدَغُ الْمُؤْمِنُ مِنْ جُحْرٍ وَاحِدٍ مَرَّتَيْن warned us "A believer is not stung twice (by something) out of one and the same hole." (Sahih al-Bukhari 6133). As Muslims we have participated in the 'democratic hole' of trial and error since 1963 hoping that our dejected situation will change but things are getting harder as days pass such as being oppressed and massacred in pretext of fighting terrorism and extremism etc. Prophet الْحَلَالُ بَيِّنٌ وَالْحَرَامُ بَيِّنٌ وَبَيْنَ ذَلِكَ " (saw) said: (أُمُورٌ مُشْتَبِهَاتٌ لاَ يَدْرِي كَثِيرٌ مِنَ النَّاسِ أَمِنَ الْحَلاَلِ هِيَ أَمْ مِنَ الْحَرَامِ فَمَنْ تَرَكَهَا اسْتِبْرَاءً لِدِينِهِ وَعِرْضِهِ فَقَدْ سَلِمَ وَمَنْ وَاقَعَ شَيْئًا مِنْهَا يُوشِكُ أَنْ يُوَاقِعَ الْحَرَامَ كَمَا أَنَّهُ مَنْ يَرْعَى حَوْلَ الْحِمَى يُوشِكُ أَنْ يُوَاقِعَهُ أَلاَ وَإِنَّ لِكُلِّ مَلِكٍ حِمَّى The lawful is clear and أَلاَ وَإِنَّ حِمَى اللَّهِ مَحَارِ مُهُ the unlawful is clear, and between that

are matters that are doubtful (not clear); many of the people do not know whether it is lawful or unlawful. So whoever leaves it to protect his religion and his honor, then he will be safe, and whoever falls into something from them, then he soon will have fallen into the unlawful. Just like if someone grazes (his animals) around a sanctuary (boundary), he would soon wind up in it. Indeed, for every king is a sanctuary (boundary), and indeed Allah's sanctuary is what He made unlawful." (Jami` at-Tirmidhi 1205) and Allah (swt) إِنَّ ٱلدِّينَ عِندَ ٱللَّهِ ٱلْإِسْتُلَمُّ says: "Indeed, the religion (Ideology) in the sight of Allah is Islam" (Aal-Imran 3: 19). In addition, He (swt) says: وَمَن لَمَ And" يَحْكُم بِمَا أَنزَلَ ٱللهُ فَأُوْلَبَكَ هُمُ ٱلْكَفِرُونَ whoever does not judge by what Allah has revealed - then it is those who are the disbelievers" (Al-Ma'idah 5: 44). Therefore, joining these groups or others founded upon the secular capitalist ideology i.e. democratic political parties is out rightly prohibited in the Islamic Shari'ah (Qur'an, Sunnah, Ijma' Sahaba and Qiyas).

Since these groups are calling for man to be given powers to organize/legislate life affairs either by retaining the current 2010 Constitution or changing it using the BBI or whatever means at their disposal. Hence, making the people sovereign since its creed is secularism.

Certainly, every genuine political activist is aware that these groups are plotting for their selfish interests and those of their Western masters. So, the activists will be looking for a sincere alternative change that will deliver true victory for the people in Kenya and across the world. Do not delay, the time for guesswork is finished and now is an opportunity to rewrite the wrongs with good by participating in that which gives life by responding to what Allah (swt) call us to: يَنَايَّهُ الدَينَ عَامَنُوا ٱستَجَعِيبُوا اللَّهُ وَٱعْلَمُوَا أَنَّ ٱللَهَ يَحُولُ وَلِلرَّسُولِ إِذَا دَعَاكُمْ لِمَا يُحْيِيكُمْ وَٱعْلَمُوَا أَنَّ ٱللَهَ يَحُولُ

"O you who have believed, respond to Allah and to the Messnger when he calls you to that which gives you life. And know that Allah intervenes between a man and his heart and that to Him you will be gathered." (Al-Anfal 8: 24). Secular capitalist ideology and its systems has miserable failed living things due to its corruption that permeates the land and sea.

This is an opportunity to for people to compete not for world accumulation as we warned by Allah (swt: (At-Takathur 102: 1 - 2). Instead we must race for doing every good especially working for the reestablishment of the Khilafah since it is the moth):

Furthermore, the Prophet (saw) prophesized about the return of the Khilafah when he (saw) ثم تكون ملكاً جبريا، فتكون ما شاء الله أن ",said تكون، ثم يرفعها إذا شاء أن يرفعها، ثم تكون خلافة على Then there will be a "منهاج النبوة، ثم سكت tyrannical rule, it will be there as long as Allah wishes it to be there then Allah will remove it when He wishes to remove it, then there will be Khilafah upon the methodology of Prophethood," then he remained silent. [Ahmad].

In conclusion, the so called hustler and dynasty groups or others like them are seeking to displease Allah (swt) by maintaining status quo that give legislative powers to man with a limited mind. Instead, we must work for the reestablishment of the Khilafah that will rule humanity based on the Islamic Shari'ah emanating from the Creator and Organizer of the universe, man and life.

While commenting on the obligations of the state towards it citizens in Kisauni, Dr. Fred Matiangi said, *"The ministry is working on such places ... you can testify that for the last four or five days you have not heard anything from Kisauni. Our responsibility is to take care of the people and that is what we are going to do."*

It's true the work of states is to look after the affairs of people and indeed health is part of these affairs enshrine in the constitutions as a basic right. Since secular states do not walk the talk, rights including health has been seen less as a privilege instead and as such the cost of Medicare as arose to be among one of the biggest problem in the world. "Some high end hospitals in Nairobi are charging as high as ksh 200,000 per day and now the rich people are now finding it hard to sustain themselves in the hospitals while the medical insurance company are also in tight corner as they wee not prepared for this new health challenge." Said a Doctor a mid this Covid 19 pademic.

Profits for the five largest for-profit health insurance companies for the **first six months of 2012 was \$6.548 billion.**



By looking health as privilege states have allocated less funds and resources there by allowing private individuals and insurance company driving the sector for the purpose of making profit thereby hiking the cost of medical care.

In an interview with the Daily Nation, Dr Stephen Ochiel, the chairman of the Private Practice Committee of the Medical Practitioners and Dentists Board, said private hospitals are businesses, just like hotels.

When states failed to allocate resources, little was done in conducting researches and develop medicines within the border so as to reduce the cost of medicines and thus sparing the country from the spirit of 'tenderpreneurship' where brokers charge extra fees for importing drugs and equipment. These additional costs are inturn, passed to the patient hence making the cost of medicare high and an bearable. Dr Ochiel maintained that Kenyans make the mistake of comparing the cost of medical care in India and Kenya yet the latter imports most of its drugs and medical equipment while the Asian country manufactures the medicines.

World Health Organisation director general Tedros Adhanom Ghebreyesus on seeing the cost of medicare was too high thus would one day cause jitters to the rulling system, urged countries to strengthen their systems for providing healthcare to all. Universal healthcare coverage, where resources are pooled to provide services to all, was thus tauted as one of the solutions to this matter.

UHC requires insurance, meaning that the health care would be subjected to the mercy of insurance companies who would in turn be deducticting premiums every month and provide acces to medication to only those that are members. It should be understood that most Kenyans get coverage through their employers who have already deducted them premiums from their salaries, but others sign up for private insurance schemes. Majority of Kenyans do not have health insurance cover.



According to NHIF DATA out of 40 million only very few Kenyans people are covered. In American 50 million people do not have health insurance and Approximately 18,000 of the 50 million die every year because they do not have health insurance

Taking care of people's affairs including health is reaponsibility of the ruler. The Prophet {saw} said: "*Each of you is a guardian and is responsible for those whom he is in charge of. So the ruler is a guardian and is responsible for his subjects."* [**Bukhari & Muslim].** Also he SAW said, "*He who has been ruler over ten people will be brought shackled* on the Day of Resurrection till justice loosens his chains or tyranny brings him to destruction." [Tirmidhi], This therefore mandates Khalifah to care for every citizen's need and ensure that they are not facing any undue hardships including lack of access to healthcare or even long wait times.

When Umar ibn Abdul Aziz was the Khalifah and once seen to be rather gloomy. His servant asked him why he was so sad and worried. Umar replied, "Anyone in my shoes should be so; I must deliver and grant all the nation's citizens all their rights, whether they demand them or not."

The fact that He SAW a signed a doctor to the umma despite being gifted show that the Khilafah state has no otherwise but provide free health care for all.

This therefore mandates Khalifah to allocate funds sufficient for free health care for all. If sufficient funds are not available then he imposes a wealth tax upon the wealth of his citizen to meet the budget deficit since healthcare is one of the interests of Muslims.

The funds would not only cover for free health care but also Provides a means to excel in MEDICAL FIELD and this will include proper health facilities and personnel, proper health education curriculum, institutions, research centers, and proper health civic education.

During the Khilafah era hospitals and doctors were deployed in several of its cities: Baghdad alone had sixty hospitals with in-patient and out-patient departments and over 1,000 physicians. Public hospitals like the Bimaristan al-Mansuri Hospital, established in Cairo in 1283, had accommodation for 8,000 patients with two attendants for each patient who did everything for his/her comfort and convenience and every patient had his/her own bed, bedding and vessel for eating. It treated inpatients and out-patients giving them free food and medicine.

The Khalifah, Al-Muqtadir Billah during his reign ordered that every mobile hospital unit should visit each village and remain there for some days before moving to the next. This therefore shows that The Khilafah would have Mobile dispensaries and clinics for the proper medical care of the disabled and those living in the villages.

The Khalefah will appoint a director in charge of the department of health thus replacing the ministry of health and spare ring doctors all the administrative work so as to concentrate on their

profession. The department will devote its efforts to treating the people by increasing the number of specialized and resident doctors and as well as having hospitals everywhere. Focus shall also be on inventing medicine by encouraging scientists to carry out researches to find cures for various diseases, making all medical equipment available in villages and cities, posting doctors all around the country including villages, supervise doctors' work until mismanagement and malpractices are eradicated, and to make sure that patients get proper treatment, implant Islamic culture and humanitarian concepts among the medical staff in order to revive their dedication, coordinate with the faculties of medicine and pharmacy in order to increase practical experience among future graduates, so that their studies become more realistic and practical rather than merely academical, establish a prevention policy so as to protect people against fatal diseases by promoting awareness among citizens and be in charge of social security, which will include looking after the elderly, needy and handicapped.

HOW ISLAM WILL PROVIDE MORE ROOMS FOR THE DEAD

Upon the increased cases of Covid 19 deaths, there has been fears that there would be many deaths with little space to bury since most cemetery in Kenya were nearing their full capacity. With such reality in mind, the family of Ursula Buluma, a former KPA worker counted their self-lucky when they secured a place in Mbarakai cemetery at a cost of ksh 6000. *"Yes I know Mbaraki one is nearly full but at the moment we are not in any crisis because we still have other cemeteries that's till have space for more graves."*

Said Mr. Nato Nyongesa of Mombasa County Environment Executive. Makaburini Grave yard is said to be the largest in Mombasa Countyand with regard to it Mr. Nyongesa said,"it has also enough space but the only challenge is encroachment."

On 8th April 2020, Health secretary, Hitan Majevda of Nairobi County admitted that "there is no space at Langata cemetery and the County has not yet found an alternative land...we have been advising the public to either bury their loved ones in upcountry or use private burial sites.....Nowadays cremation has been adopted by people outside Hidu religion. ...I would advise people to use that method to avoid incurring additional burial expenses." On June 2, 2015 the head of Nakuru county Health Department, Dr Mungai Kabii issued a notice for the closure of both North and South cemeteries of Nakuru.

This came after a similar notices was issued to the public cemeteries of Naivasha and Molo sub-counties. It was no secret that the cementires for Nakuru county were nearly full and this prompted the then Bahati MP Kimani Ngunjiri complaining that bodies were now being buried a top others and as well some of the bereaved were now burying their dead on pathways, while others were concreting graves so that they were not resold. Although the County Government had allocated Sh84 million to buy a new land for burial of the dead, option of cremating the dead was then being sold to the locals as a permanent solution to the overcrowding of cemeteries.



Dr. kabii said *." local people are now* being asked to consider cremating the dead, but this is meeting resistance,"

Ever since man carried the concept of materialism; matters regarding death has received no big attention. Materialism has made man focused more on world life to the extent of forgetting to prepare for what comes after death. Allah says:

ِبَنَى زُرْتُمُ الْمَقَابِرَ, "Engageth you (your) vying in exuberance. Until you visit the graves."TMQ102.1-2.

This therefore has made many capitalist states having the problem of overcrowding of the cemeteries. In addition to that, materialism has made the land meant for burial see it self-get grabbed and as well turned in to dumpsites. In other succumstance, cemeteries have found themselves not only be full but also be turned into areas where people go for both long and short calls.

With regard to the laws regarding burial, capitalism has made it hard to find more land for burial. As a sign of frustration, Mr Kabii was heard saying, < getting land may prove to be quite difficult because the National Environment Act requires that an impact assessment be conducted before such acquisition is approved by those living around the proposed site). This therefore has made



capitalism force people to opt for cremation as a tangible solution to overcrowding of cemeteries.

In short, capitalism has failed to look and plan for our life and after life affairs. Only Islamic Ideology can help solve the cemeteries crisis.

Under Islamic ideology, the state would be obliged to secure huge chunks of land that would be enough for burial of the dead. In addition to that, the concept of swadakatul jariyah would help drive individuals donate their land to the public only to be used as a cemetery.

In case there were shortage of grave sites and no land can be provided, Islam has allowed due to **necessity** to bury two bodies together in one grave and also to dig up a grave in order to bury another body as long as the earlier body has disintegrated, decomposed and transformed into soil. The state would ensure that grave yards are secured and dead bodies are not buried at places which are disrespectful, like places where garbage is thrown. Indeed, with these and other related regulations, Islam ensures overcrowding of cemeteries is a thing of a past and the concept of cremation is not an option.

Ever since Capitalism was established, workers have never sense tranquility in their lives. The demand by capitalist to increase the supply without putting in mind workers plight has led to many attempts to organize labor's demands ////// Pg. 21

for better working conditions. Employers as such have responded with anti-union measures, such as firing and blacklisting union members, locking out workers, recruiting strikebreakers; employing spies, thugs, and private security forces and exacerbating ethnic tensions in order to divide the workers.

Despite setting special measures such that include Labour minisistry, Remuneration Committee and special recognition day for workers so has to address their plight, capitalism has always ensure such measures are just a fallacy. History as well as statistics have shown measures such as formation of indusrial courts, right to strike, right to form labour unions and so forth have always been made un effective tools that in the end provide no solution to workers plight that include (1) long working hours, almost without adequate rest periods, (2) low salaries, which are often not paid on time, and (3) arbitrary actions of employers who physically and sexually abuse them

For sure workers demand better pay, good working conditions as well as good employer employee relation. Indeed Islam inform workers that capitalism has failed them and only Islamic labour laws under the Khilafah state is their salvation. Under the Khilafah, the Khalifah would enforce the Islamic labour laws and policies. The Islamic policy would create a distinctive identity in the community that would define the status of people upon their tagwa, and not their wealth or any other physical attributes. As such , this would never put the material value above morality, or place money above the dignity of human beings, regardless of the scale of economic gain. This breaks the materialistic personality, whose focus is only on money and material matters regardless of the consequences upon others, minimizing exploitative and unjust behavior towards others. Hence the Islamic labour policy would never split the society into two segregate classes, the working class and business class. Rather it would build a unique equal relationship between the worker and the employer, which is based upon the sense of responsibility to fullfil the



rights and obligations of each other as Islam ordered. In fact Islam states that unclear agreement points within an ijarat transaction qualifies it as a fasid (broken) agreement. With clear and detailed provisions in the ijarat al-ajir transaction, each party would be made to understands his rights and obligations hence providing protection against tyrannical employers forcing workers to work outside their defined hours as in the case of domestic workers.

Imam Bukhari narrated from Abu Hurairah (ra), the Prophet {saw}said, Allah {SWA}said:

"Allah said: There are three persons whom I will oppose on the Day of Resurrection: a man who gives his word



by Me but proves treacherous; a man who sells a free person and consumes the price; and a man who employs a worker and receives a completed job but he does not pay him his wages." [Sahih Bukhari, Number 430]

Also, the Islamic policy would make no distinction between so-called whitecollar workers and blue-collar workers. This is because all of them are called ajir (employees), whether the work they do is more intellectual in nature such as doctors, lecturers, or journalists, or physical in nature such as maids and factory workers. As mentioned in Hizb ut Tahrir's draft constitution for the Khilafah, Article 154 states, "Company employees and the self-employed have the same rights and duties as employees of the State. Everyone who works for a wage, irrespective of the nature of the work, is considered an employee..." For sure such a policy would ensure casual laborers are indeed entitled for annual leave just like any other worker.

Surely there would be many measures employed by capitalist nations so as to solve workers plight but as long as these measure emanates from corrupt capitalist creed workers plight would always continue. Indeed workers must understand the evil of capitalism for the moment they do, a strong wave of public opinion and awareness would get up in arms calling for ideological change that would be indeed unstoppable. For sure the power of workers is incredible.
