

Has Not the Anti-Terrorism Law Meant to Combat Islam??

Immediately after the lynching of the three Muslim girls, who were suspected of assaulting the Central Police in Mombasa, as usual this incident has been ostensibly taken to combat extremism, nevertheless in reality, it's a means meant to terrorize the Muslim community in their own homes. The most important issue here is to know the effects/outcome that usually ensue after such sad incidents. We, **Hizb ut Tahrir Kenya**, therefore take this opportunity to elucidate on the following points:

Firstly: Since the promulgation of the Anti-Terror Bill, it is as clear as the thunder that the police have been indulging in extra judicial killings, very often, without neither profound investigation into the matter, nor court order. Police are often accused of raiding suspects' homes, planting weapons and shooting the suspects. We would like to sternly warn that this occurrence should not be used as usual to continue in the oppression of the Muslim communities which have now reached the peak, of intimidating Muslims to the extent of fearing to adhere to their religion.

Secondly: The main headline from the mainstream media: 'they were veiled terrorists clad in buibui black clothing worn by Muslim women that cover their bodies]", clearly indicates the role of the media that they closely work together with the government in the war against Islam. The media is deliberately creating public opinion to demean Muslims; and their attires are a potent threat to security. Yet the truth is that Islam is an ideology that stands against any sort of oppression and unscrupulous bloodshed.

Thirdly: Bad foreign policy of the western states blended with unsavory if not devious antiterror laws instigates more acts of terror! Islam has gravely forbidden the invasion of a country for the sole purpose of stealing their natural resources and their colonization since that contribute to the acts of dearth of security.
